## **Terms and Conditions**

**\*\*Terms and Conditions for Paragliding Flight School\*\***

### **\*\*1. Introduction\*\***

These Terms and Conditions govern the relationship between the paragliding flight school, owned by Leonardo Cardenas Rey, and the participant ("pilot") booking any courses offered by the flight school. By booking a course with us, the pilot agrees to abide by these Terms and Conditions.

### **\*\*2. Course Offerings\*\***

Our flight school offers beginner, intermediate, and advanced courses in paragliding. The beginner course follows the structure of the APPI system. Participants can attain certification as "APPI 3 PILOT" after completing a 15-day course or receive a confirmation of training after 10 days as "APPI 2 Explorer". Further details on the APPI system can be found on the APPI website. Leonardo Cardenas Rey, the owner, is a certified APPI instructor and certified instructor by the Colombian Paragliding Federation.

### **\*\*3. Booking and Deposit\*\***

To secure a place in any of our courses, the pilot must transfer 30% of the course price as a deposit. Upon receipt of the deposit in our account, the participant's place is confirmed. By making the deposit, the pilot confirms that they have read, understood, and acknowledged these Terms and Conditions.

### **\*\*4. Services Included\*\***

Services included in the course are explicitly stated in the offer, on our website, and/or on the invoice. No additional services beyond those mentioned in the offer, website, or invoice can be claimed by the pilot.

### **\*\*5. Photography Consent\*\***

The participant agrees that the flight school may take and use their pictures for advertising purposes.

### **\*\*6. Participant Requirements\*\***

Participants must be in good health and have no known illnesses or disabilities that could hinder or pose a danger to them during paragliding activities. Any such illnesses or disabilities must be communicated to the flight instructor before participating.

### **\*\*7. Liability\*\***

The flight school, Leonardo Cardenas Rey and any other instructors who act on behalf of Leonardo Cardenas Rey do not accept liability or responsibility for any injuries or damages resulting from the paragliding activity itself or that occur from simple neglect of instructions from the flight instructors. Pilots must have insurance covering injuries, hospital stays, and repatriation from Colombia if necessary.

### **\*\*8. Cancellation Policy\*\***

- If a booked course is cancelled up to 45 days before the start of the course, the deposit minus cancellation costs for already booked services (e.g., transport, takeoff, equipment) will be refunded.
- If the course is cancelled 44 to 20 days before the start, 60% of the deposit will be retained by the organizer.
- If the tour is cancelled later than 20 days before the start, 100% of the deposit will be retained by the organizer.

### **\*\*9. Shortened Courses\*\***

In the event that a course needs to be shortened due to unforeseen circumstances by the participant, the flight school does not refund any missing days as courses are booked as packages.

### **\*\*10. Travel Expenses\*\***

The flight school does not assume any costs related to the cancellation of travel expenses such as plane tickets, bus tickets, etc., to the agreed meeting point, regardless of the reason for the cancellation.

By booking a course with us, the pilot acknowledges and agrees to abide by these Terms and Conditions set forth by Piedechinche Paragliding, based in Piedechinche, Colombia, owned by Leonardo Cardenas Rey.
